# Stock transfer

---

Fuller may receive gifts of stock through our Vanguard brokerage account. Gifts of shares going into a Vanguard Brokerage Account are processed electronically through the Depository Trust Company (DTC) and generally take 1-3 business days to complete.

To make the gift, contact your brokerage firm and request a form to gift shares of securities from your brokerage account to an outside firm (in this case, Vanguard Brokerage). You will need to give your broker the following information:
